After discussion, Raford Hargrove made the motion to approve the 2026 Fisher County Appraisal District budget, second by Chris Kiser, motion carried unanimously.


In the Chief Appraiser's Report, Holly Bufkin, Assistant Chief Appraiser updated the board on her training and testing.
